

**ORDINANCE AMENDMENT 2026-01**

**AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF MESERVEY, IOWA, 2012, BY AMENDING PROVISIONS PERTAINING TO BILLING FOR WATER SERVICE.**

BE IT ENACTED by the City Council of the City of Meservey, Iowa:

SECTION 1. Chapter 92, Section 92.02 and 92.05(4) of the Code of Ordinances of the City of Meservey, Iowa, 2012 is hereby repealed and replaced with the same:

**92.02 RATES FOR SERVICE.** Water service shall be furnished at the following monthly rates within the City: *(Code of Iowa, Sec. 384.84)*

\*Rates effective January 1, 2026

<b>Gallons Used Per Month</b>	<b>Rate</b>
First 1,000 gallons (minimum bill)	\$41.00
All over 1,000 gallons	\$5.50 per 1,000 gallons
Bulk water rate is \$25.00 per 1,000 gallons	

\*Rates effective July 1, 2027

<b>Gallons Used Per Month</b>	<b>Rate</b>
First 1,000 gallons (minimum bill)	\$45.00
All over 1,000 gallons	\$6.00 per 1,000 gallons
Bulk water rate is \$25.00 per 1,000 gallons	

\*Rates effective July 1, 2028

<b>Gallons Used Per Month</b>	<b>Rate</b>
First 1,000 gallons (minimum bill)	\$72.00
All over 1,000 gallons	\$6.50 per 1,000 gallons
Bulk water rate is \$25.00 per 1,000 gallons	

**92.05 SERVICE DISCONTINUED.** Water service to delinquent customers shall be discontinued in accordance with the following: *(Code of Iowa, Sec. 384.84)*

4. Fees. A fee of fifty dollars (\$50.00) shall be charged before service is restored to a delinquent customer. No fee shall be charged for the usual or customary trips in the regular changes in occupancies of property.

SECTION 2. Severability.

- 1. All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.
- 2. The invalidity of any section, clause, sentence or provision of this Ordinance shall not affect the validity of any other part of this ordinance which can be given effect without such invalid part or parts.

SECTION 3. Ordinance in force.

- 1. This Ordinance shall be in effect from and after its final passage, approval, and publication as provided by law.
